- ♦ Non-member applications will be accepted at the organiser's discretion.
- ♦ Participants will be responsible for injury to other players caused by recklessness, carelessness and/or wilful misconduct. The organiser has the sole discretion to suspend participants whose conduct is considered inappropriate, with no refund of registration fee.
- ♦ All participants must wear a properly approved personal flotation device at all times while on or near the water.
- ♦ Participants must wear running shoes. No cleats, flip flops or bare feet allowed. Shin guards are strongly recommended. Team shirts will be provided.
- ♦ Refreshments are available for purchase at Coney Beach and will be provided by parents.

I hereby covenant and agree not to make any demands, or claims, or bring any suit or actions against RLWYC, its organizers, promoters, or sponsors, or any of its respective agents, officials, authorities, officers, representatives, instructors, students, or designates, whether volunteer or otherwise, with respect to any event whatsoever arising out of, caused by or resulting from my participation directly or indirectly in any RLWYC activity (including without limitation all races, competitions, courses, games, classes and other functions).
